

NOTICE OF PROPOSED CLASS ACTION SETTLEMENT

Lawrence Hannity, Jr., v. Furman Foods Inc. d/b/a Furmano's.

Case No. CV-25-528

A court has authorized this Notice. This is not a solicitation from a lawyer.

You are not being sued.

Please read this Notice carefully and completely.

- A Settlement has been reached with Furman Foods Inc. (“Furmano’s” or “Defendant”) in a class action lawsuit. This case is about the targeted cyberattack on Furman Foods’ computer systems that occurred in October 2024 (the “Data Incident”). Certain files that contained Personal Information were accessed. These files may have contained Personal Information such as names; addresses; and Social Security numbers.
- The lawsuit is called *Lawrence Hannity, Jr., v. Furman Foods Inc. d/b/a Furmano's.*, Case No. CV-25-528. It is pending in the Court of Common Pleas of Northumberland County, Pennsylvania (the “Litigation”).
- Furman Foods denies that it did anything wrong, and the Court has not decided who is right.
- The Parties have agreed to settle the lawsuit (the “Settlement”) to avoid the costs and risks, disruptions, and uncertainties of continuing the Litigation.
- Furman Foods’ records indicate that you are a Class Member and are entitled to benefits under the Settlement. You may have received a previous notice directly from Furman Foods.
- Your rights are affected whether you act or don’t act. ***Please read this Notice carefully and completely.***

Basic Information

1. Why was this Notice issued?

The Court of Common Pleas of Northumberland County, Pennsylvania, authorized this Notice. You have a right to know about the proposed Settlement of this class action lawsuit, and about all of your options, before the Court decides whether to grant final approval of the Settlement. This Notice explains the lawsuit, your legal rights, what benefits are available, and who can receive them.

The lawsuit is called *Lawrence Hannity, Jr., v. Furman Foods Inc. d/b/a Furmano’s*, Case No. CV-25-528. It is pending in the Court of Common Pleas of Northumberland County, Pennsylvania. The person that filed this lawsuit is called the “Plaintiff” (or “Class Representative”) and the company sued, Furman Foods Inc., is called the “Defendant.”

2. What is this lawsuit about?

This lawsuit alleges that during the October 2024, targeted cyberattack on Furman Foods’ computer systems, certain files that contained Personal Information were accessed. These files may have contained Personal Information such as names; addresses; and Social Security numbers.

3. What is a class action?

In a class action, one or more individuals sue on behalf of other people with similar claims. These individuals are called the “Plaintiffs” or “Class Representatives.” Together, the people included in the class action are called a “Class” or “Class Members.” One court resolves the lawsuit for all Class Members, except for those who opt out from the settlement. In this Settlement, the Class Representative is Lawrence Hannity Jr. Everyone included in Settlement Class is a Class Member.

4. Why is there a Settlement?

The Court did not decide whether the Plaintiff or the Defendant is right. Both sides have agreed to a Settlement to avoid the costs and risks of a trial, and to allow the Class Members to receive benefits from the Settlement. The Plaintiff and Class Counsel think the Settlement is best for all Class Members.

Who is in the Settlement?

5. Who is included in the Settlement?

The Court has defined the Class this way: “All individuals residing in the United States whose Personal Information was potentially compromised in the Data Incident affecting Defendant which occurred in October 2024, including all those individuals who received notice of the Data Incident.”

6. Are there exceptions to being included?

Yes. Excluded from the Class are: (1) the Judge in this case, and the Judge’s family and staff; (2) Furman Foods and its subsidiaries, parent companies, successors, predecessors, and any entity in which Defendant or its parents have a controlling interest; (3) anyone who validly excludes themselves from the Settlement; and (4) anyone who perpetrated the Data Incident.

The Settlement Benefits

7. What does the Settlement provide?

Furman Foods has agreed to provide a number of benefits for Class Members. All Class Members are eligible to enroll in two years of **Credit Monitoring Services**. In addition, Class Members may choose between one of two **Payment** options:

OPTION 1: Select one or more of the following payments:

- Out-of-Pocket Expenses
- Losses for Identity Theft or Fraud
- Payment for Lost Time

OR

OPTION 2: Alternative Payment.

- Receive a one-time \$35.00 payment

The benefits are explained in more detail below.

CREDIT MONITORING SERVICES. All Class Members are eligible to enroll in two years of Credit Monitoring Services from a major credit bureau. This benefit comes with \$1 million in identity theft insurance, and includes:

- real time monitoring of your credit file
- dark web scanning
- comprehensive public records monitoring

If anything suspicious happens, you will be able to talk to a fraud resolution agent to help fix any problems.

PAYMENT OPTION 1. You may claim one or more of the following payments, as they apply to you.

Out-of-Pocket Expenses. If you incurred actual, documented out-of-pocket expenses due to the Data Incident, you can get back up to **\$300.00**. The losses must have occurred between October 10, 2024, and September 30, 2026.

This benefit covers out-of-pocket expenses like:

- fees for credit reports, credit monitoring, or freezing and unfreezing your credit
- cost to replace your IDs
- postage to contact banks by mail

You need to send proof, like receipts, to show how much you spent or lost. You can also send notes or papers you made yourself to explain or support other proof, but those notes or papers alone are not enough to make a valid claim.

Losses for Identity Theft or Fraud. If you lost money because of identity theft or fraud, you can get back up to **\$2,000.00**.

You will need to show that:

- the theft or fraud was probably caused by the Data Incident
- the losses are not already covered by **Out-of-Pocket Expenses**
- you tried to prevent the loss or get your money back, such as by using insurance you already have

The losses must have occurred between October 10, 2024, and September 30, 2026.

You need to send proof, like receipts, to show how much you spent or lost. You can also send notes or papers you made yourself to explain or support other proof, but those notes or papers alone are not enough to make a valid claim.

Payment for Lost Time. Class Members who spent time responding to the Data Incident may claim up to five hours, at \$20.00 per hour, for a maximum of **\$100.00**. This payment counts toward the \$300.00 cap for Out-of-Pocket Expenses.

You must have spent the time on tasks related to the Data Incident, and provide a short description of what you did. Some examples include things like:

- changing your passwords
- investigating suspicious activity in your accounts
- researching the Data Incident

PAYMENT OPTION 2. Instead of any of the payments in Option 1, you may claim a one-time **\$35.00 Alternative Payment**.

8. What claims am I releasing if I stay in the Class?

If you stay in the class, you won't be able to be part of any other lawsuit against Furman Foods about the issues that this Settlement covers. The "Releases" section of the Settlement Agreement (Section IX) describes the legal claims that you give up if you remain in the Class. The Settlement Agreement is available at www.FurmanFoodsDataSettlement.com.

Submitting a Claim Form for a Settlement Payment

9. How do I submit a claim for a Settlement benefit?

The fastest way to submit your Claim Form is online at www.FurmanFoodsDataSettlement.com. If you prefer, you can download a printable Claim Form from the website and mail it to the Settlement Administrator at:

10. Are there any important Settlement deadlines?

If you are submitting a Claim Form online, you must do so by September 30, 2026. If you are submitting a claim by U.S. mail, the completed and signed Claim Form, including supporting documentation, must be postmarked no later than September 30, 2026.

11. When will the Settlement benefits be issued?

The Court will hold a Final Approval Hearing on a date and at a time to be set by the Court, (**see Question 18**). If the Court approves the Settlement, there may be appeals. We do not know if appeals will be filed, or how long it will take to resolve them if they are filed.

Settlement payments will be distributed if the Court grants final approval, and after any appeals are resolved.

The Lawyers Representing You

12. Do I have a lawyer in the case?

Yes, the Court has appointed attorney Cassandra P. Miller of Strauss Borrelli PLLC, to represent you and other Class Members ("Class Counsel").

13. Should I get my own lawyer?

You will not be charged for Class Counsel's services. If you want your own lawyer, you may hire one at your expense.

14. How will Class Counsel be paid?

Class Counsel will ask the Court to approve \$125,000.00 as reasonable attorney's fees and costs of litigation. This amount will be paid by Furman Foods.

Class Counsel will also ask for a Service Award Payment of \$5,000.00 for the Class Representative. This amount is separate from the Settlement benefits available to Class Members.

Excluding Yourself from the Settlement

15. How do I opt out of the Settlement?

If you do not want to be part of the Settlement, you must formally exclude yourself from the Settlement. This is called a Request for Exclusion, and is sometimes also called "opting out." If you opt out, you will not receive Settlement benefits or payment. However, you will keep any rights you may have to sue Furman Foods on your own about the legal issues in this case.

If you exclude yourself, you are telling the Court that you do not want to be part of the Settlement. You will not be eligible to receive any Settlement benefits if you exclude yourself.

The deadline to exclude yourself from the Settlement is **August 31, 2026**.

To be valid, your Request for Exclusion must have the following information:

- (1) the name of the Litigation: *Lawrence Hannity, Jr., v. Furman Foods Inc. d/b/a Furmano's*, Case No. CV-25-528, pending in the Court of Common Pleas of Northumberland County, Pennsylvania;
- (2) your full name, mailing address, telephone number, and email address;
- (3) personal signature; and
- (4) the words "Request for Exclusion" or a clear and similar statement that you do not want to participate in the Settlement.

You may only exclude yourself—not any other person.

Your Request for Exclusion must be submitted, postmarked, or emailed by **August 31, 2026**.

Commenting on or Objecting to the Settlement

16. How do I tell the Court if I like or do not like the Settlement?

If you are a Class Member and do not like part or all of the Settlement, you can object to it. Objecting means telling the Court your reasons for why you think the Court should not approve the Settlement. The Court will consider your views.

You cannot object if you have excluded yourself from the Settlement (**see Question 15**).

You must provide the following information for the Court to consider your objection:

- (1) the name of the Litigation: *Lawrence Hannity, Jr., v. Furman Foods Inc. d/b/a Furmano's*, Case No. CV-25-528, pending in the Court of Common Pleas of Northumberland County, Pennsylvania;
- (2) your full name, mailing address, telephone number, and email address;
- (3) a clear description of all the reasons you object; include any legal support, such as documents, you may have for your objection;
- (4) if you have hired your own lawyer to represent you at the Final Approval Hearing, provide their name and telephone number;
- (5) if you or your lawyer have objected in any other cases in the past three years, list the names, courts, and civil action numbers for each of those cases;
- (6) whether or not you or your lawyer would like to speak at the Final Approval Hearing;
- (7) your signature (or, if you have hired your own lawyer, your lawyer's signature).

For your objection to be valid, it must meet each of these requirements.

To be considered by the Court, you must submit your written objection to the Settlement Administrator and file it with the Court by August 31, 2026.

17. What is the difference between objecting and excluding?

Objecting is telling the Court that you do not like something about the Settlement. You can object to the Settlement only if you do not exclude yourself from the Settlement. Excluding yourself from the Settlement is opting out and stating to the Court that you do not want to be part of the Settlement. If you opt out of the Settlement, you cannot object to it because the Settlement no longer affects you.

The Court's Final Approval Hearing

18. When is the Court's Final Approval Hearing?

The Court will hold a Final Approval Hearing on a date and at a time to be set by the Court. The date, time, and location of the Final Approval Hearing will be posted on the Settlement Website at www.FurmanFoodsDataSettlement.com once scheduled.

At the Final Approval Hearing, the Court will decide whether to approve the Settlement. The court will also decide how Class Counsel should be paid, and whether to award a Service Award Payment to the Class Representative. The Court will also consider any objections to the Settlement.

If you are a Class Member, you or your lawyer may ask permission to speak at the hearing at your own cost (**See Question 16**).

The date and time of this hearing may change without further notice. Please check www.FurmanFoodsDataSettlement.com for updates.

19. Do I have to come to the Final Approval Hearing?

No. Class Counsel will answer any questions the Court may have. You may attend at your own expense if you wish, but you do not have to.

If you file an objection, you do not have to come to the Final Approval Hearing to talk about it; the Court will consider it as long as it was filed on time. You may also pay your own lawyer to attend, but you do not have to.

If I Do Nothing

20. What happens if I do nothing at all?

If you do nothing, you will not receive a benefit from this Settlement. You will also give up the rights described in **Question 8**.
